The Civil Citation Program, derived from Florida Statute 985.301, was established in 1996 as a program that offers early intervention, counseling, education and other appropriate community resources to divert first time juvenile misdemeanor offenders from the Juvenile Justice system. By volunteering with this program, you have the opportunity to gain exposure to the justice system as well as develop a network of skills and professional contacts in the area of criminal justice. In addition, you will have hands-on learning and experiences with first time offenders and the process of the justice system.
