St. Francis Wildlife Association is a non-profit organization, and was founded in 1978 to provide humane care and rehabilitation for all species of sick, injured, and orphaned wildlife in North Florida and South Georgia. Each year, we receive and care for more than 3,000 animals, from hummingbirds and squirrels to bald eagles and river otters. Volunteers are needed to work in the wildlife hospital at the St. Francis Wildlife Rehabilitation Center, located on 35 secluded acres of forest, fields and ponds, four miles northwest of Havana in Gadsden County. It is just 25 minutes from downtown Tallahassee.
